Reference: Follow up correspondence in regards to proposed slaughter of street dogs in Brasov, Romania.

Please note I have chosen to send you this generic correspondence as it wholly echoes my beliefs and opinions exactly in regards to the horrific proposal to massacre the street dogs of Brasov.

I am aware that myself and thousands of others from the International Community on 13th May 2011 contacted yourself either via email, fax or telephone in regards to the above matter. I am concerned that neither myself nor any of thousands who contacted you received a reply or confirmation that this would be investigated further. Considering the current climate in regards to Romania's public image I am quite surprised at your lack of action or confirmation of receiving such communication.

In the highly unlikely event that you failed to receive one of the correspondences sent to you on 13th May from the thousands that were sent, I have taken the liberty of reiterating my concerns and previous reasons for contacting you, as well as taking advantage of this opportunity to remind you of the ramifications legally such deplorable and illegal proposed actions below may have if followed through by the authorities and their employees within the municipality of Brasov.

The horrific and illegal proposed action in Brasov: Flavius Barbulescu, director of SPGA in Brasov together with Vice Major Adrian Gabor are planning to shortly massacre the street dogs of their municipality, this would in point of fact mirror the 11th May Massacre that took place last week in Botosani that not only caused uproar within the international community, but was also in breech of a multitude of animal welfare and animal protection laws as laid down by the Romanian Government and that of the European Parliament.

Not only has such action triggered various European Parliamentary members to be requesting a revision of Romania's place within the European alliance but also official investigations into the funding it receives from the aforementioned parliament. This is not to mention the legal advice currently being sought by animal welfare groups such as A.F.R.A in regards to bringing private legal suits against various public sector individuals involved in the 11th May Massacre including the college of veterinarians for numerous suggested criminal offences of animal abuse and failure to implement and uphold Romanian animal welfare and animal protection laws. In particular the Romanian Animal Welfare Act No: 792 effective from 13th December 2001 and Romanian Animal protection law no.9/2008 effective from 15th January 2008.

In respect of the above mentioned laws being breeched in Botsani, European Parliamentary Investigations and suggestions of restrictions to EU donations and grants, I would strongly suggest you advise any persons involved with the proposed Brasov massacre to quash any such proposals immediately.

More importantly than this, the proposed street dog massacre in Brasov must not go ahead, as just like Botsani, it will be viewed as corrupt, immoral, inhumane, barbaric and wholly illegal, and the European and International community simply will no longer stand for your countries cruelty.

I do trust that you will have the politeness to confirm receipt of this correspondence and by that confirmation I have your assurance that the contents will be actioned upon immediately.
